- the quality of the maps/pictures in the questionnaire need to be enhanced as far as is possible;
- the Tree Officer would be contacted regarding the number of tree preservation orders within the Parish;
- the Clerk to provide a copy of the Veteran Tree Report produced in 2017;
- the playground at School Road is commonly known as "School Road Playpark"; and
- significant discussion was held around Page 12 and the banding for housing. It was agreed that an option for "none" had to be included.
